CORRIGENDUM (Passed on 3rd day of September 2010)

This Authority had passed an Order on 23 February 2010 in case No.TAMP/11/2009-COPT relating to the general revision of the Scale of Rates of the Cochin Port Trust (COPT). This Order and the (revised) Scale of Rates were notified in the Gazette of India Extraordinary (Part III Section 4) on 7 April 2010 vide Gazette No.82.

2. It has been noticed that some typographical mistakes have occurred in the consolidated Scale of Rates notified on 7 April 2010. The corrections to be made in the Scale of Rates are given below:

(i). **The note number (vii) under Schedule 1.2. - General terms & conditions under Chapter - I may be deleted and the subsequent items may be renumbered.**

(ii). **The following condition may be incorporated as note no.5 under the 2.2.3. (i) Shifting Fee of sailing vessels/ barges under 2.2.3 Schedule of Shifting Charge, in Chapter - II Vessel Related Charges:**

"5. In case the vessel is moved to Cochin Oil Terminal (COT) or any other berth of the Port and from there it sails out, it should be treated as a fresh entry / exit and the Pilotage as per the existing Scale of Rates of the COPT shall be charged".

(iii). **Sl.No. (1) under 2.2.3. Schedule of Berth Hire Charges for other vessels/floating crafts/bodies under Chapter - II Vessel Related Charges should be read as follows:**
