ORDER

(Passed on this 28 day of June 2007)

This Authority had passed an Order dated 25 January 2007, extending the validity of the existing Rent Schedule of Land and Buildings of KOPT at Haldia till 31 August 2007 or till the effective date of Notification of Order to be passed by this Authority on the proposal to be filed by the Kolkata Port Trust (KOPT) for revision of Schedule of rent for Land and Buildings of KOPT at Haldia and at Kolkata, whichever is earlier and directed the KOPT to file its revised proposal by 31 May 2007 latest.

2. The KOPT vide its letter dated 13 June 2007 has requested this Authority to extend the date of submission of proposal for revision of the Schedule of Rent for Land and Buildings at Haldia and at Kolkata till 31 December 2007 and extend the validity of the existing Rent Schedule of Land and Buildings of KOPT at Haldia for a period upto 31 March 2008.

3.1. As reported by the KOPT, it has already initiated action to engage a consultant for undertaking valuation of land and buildings of KOPT at Haldia and Kolkata in line with the provisions of the Land Policy Guidelines. The port has expressed certain difficulties due to which it could not file its proposal for revision of the Schedule of Rent for Land and Buildings by 31 May 2007.

3.2. This Authority is inclined to accede to the request made by KOPT to extend the time limit for submission of its revised proposal for revision of Rent Schedule for Land and Buildings at Haldia and at Kolkata and extend the validity of the existing Rent Schedule for Land and Buildings of KOPT at Haldia.

4. The validity of the existing Rent Schedule for Land and Buildings of KOPT at Haldia is extended from 31 August 2007 and shall remain valid till 31 March 2008 or till the effective date of notification of Order to be passed by this Authority on the proposal to be filed by KOPT for revision of the Rent Schedule for its Land and Building at Haldia, whichever is earlier. The KOPT is directed to file its revised proposal for revision of the Schedule of Rent for Land and Buildings of KOPT at Haldia and a proposal for Schedule of Rent for Land and Buildings of KOPT at Kolkata by 31 December 2007 latest.
