

## **TARIFF AUTHORITY FOR MAJOR PORTS**

### **The Activities of the Tariff Authority for Major Ports In the year 2017-18**

The Tariff Authority for Major Ports (TAMP) regulates the tariff of Major Port Trusts and BOT Terminals operating thereat. TAMP is an ISO 9001:2008 compliant organization for Quality Management System. It is also an ISO 27001:2013 certified organization for Information Security Management System.

2. The Board of TAMP met six times in the year 2017-18. The Board decided 51 tariff cases of various Ports including five cases of Estate related charges, surpassing the overall target of 45 tariff cases set by itself for the year 2017-18.

3. As a part of consultation process in regulating tariff, TAMP organized 32 Hearings jointly with the Ports, Port users, BOT operators and prospective bidders for Port tariff. The joint hearings gave an opportunity to the stakeholders of being heard of their views on the proposals. The discussions at the joint hearing very often throw up issues that call for further attention by the Port Trusts / BOT operators. In some cases, based on the discussions, as directed by the TAMP, the Port Trusts modified and fine tuned their proposals.

4.1 Nationwide Swachhta Abhiyaan – 2017 which has been named as “Swachhta Hi Sewa” campaign was observed from 15<sup>th</sup> September 2017 to 02<sup>nd</sup> October 2017 by conducting various activities related to cleanliness. During the Swachhta Hi Sewa campaign Slogans, Banners and placards were displaced in order to bring awareness and to motivate the employees on cleanliness drive etc. All the senior level officials and staff whole heartedly participated in the Swachhta Hi Sewa campaign. Beside this, all the activities pertaining to Swachhata Plan has also been uploaded on ‘Swachhta Hi Sewa Portal’. Further, as per directives issued by the Ministry of Shipping and Ministry of

Drinking Water and Sanitation (DWS) and to continue the mission, 'Swachhta Action Plan' (SAP), Special Cleanliness Drive was observed every month.

4.2. Hindi Pakhwada was conducted in the second fortnight of September 2017. Various competitions were held, wherein all the TAMP Officers and Staff participated.

4.3. The Vigilance Awareness Week was observed between 30<sup>th</sup> October 2017 to 4<sup>th</sup> November 2017.

5. TAMP maintains a website since the year 2001. The website is updated regularly and all the orders passed by TAMP from January 2000, Tariff Guideline formats for filing tariff proposals, RTI related details etc., are posted in the website. The website also contains a provision to receive feedback from public. The TAMP website is bilingual and is GIGW compliant. TAMP has obtained the Standardization Testing Quality (STQC) Certification of the re-developed website.
